### Capital allowances

Our capital allowances service can be applied at each stage of the property investment lifecycle:

- Pre-purchase/ pre-construction: We can provide pre-contract advice on property acquisitions to ensure a client's capital allowances are identified and dealt with effectively. We undertake assessment of new construction projects, refurbishments and fitting out works to understand and maximise the availability of plant and machinery allowances, structures and buildings allowances and other related tax reliefs.

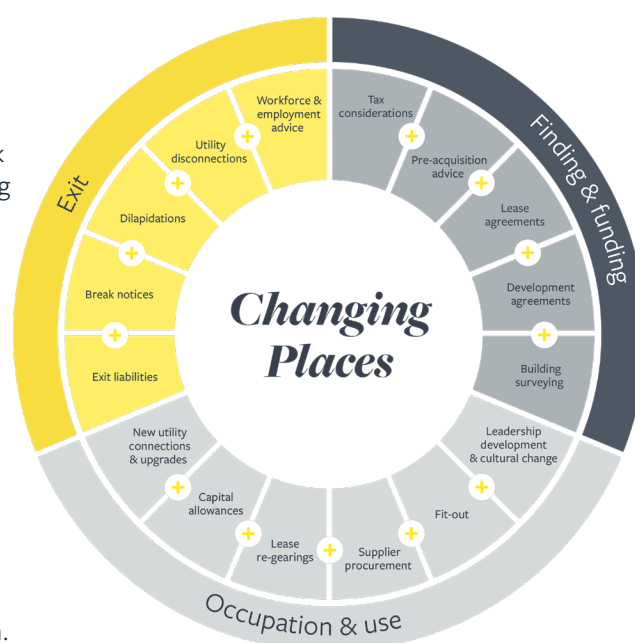
